ADMINISTRATIVE PANEL DECISION

SellAnyCar.com FZE vs. Motor Expert Car Trading LLC
Case No. **A2016-0001**

1. The Parties

The Complainant is SellAnyCar.com FZE address SAIF Office P8-09-16 Sharjah, UAE, represented by Al Tamimi & Co.

The Respondent is Motor Expert Car Trading LLC represented by Emirates Intellectual Property Services (EIPS).

2. The Domain Name and Registrar

The disputed domain names are simplysellanycar.com & simplybuyanycar.com registered with Name.com (the "Registrar").

3. Procedural History

The Complaint was filed with the Arab Center for Dispute Resolutions (ACDR) on April 24th, 2016. On April 28th, 2016, the Center transmitted by email to the Registrar a request for registrar verification in connection with the disputed domain name. On April 29th, 2016, the Registrar transmitted by email to the Center its verification response confirming that the Respondent is listed as the registrant and providing the contact details.

The Center verified that the Complaint satisfied the formal requirements of the Uniform Domain Name Dispute Resolution Policy (the "Policy" or "UDRP"), the Rules for Uniform Domain Name Dispute Resolution Policy (the "Rules"), and the ACDR Supplemental Rules for Uniform Domain Name Dispute Resolution Policy (the "Supplemental Rules").



In accordance with the Rules, paragraphs 2 and 4, the Center formally notified the Respondent of the Complaint, and the proceedings commenced on March 2, 2016. In accordance with the Rules, paragraph 5, the due date for Response was March 22, 2016. The Respondent did not submit any response. Accordingly, the Center notified the Respondent's default on May 18th, 2016.

The Center appointed Charles Shaban as the sole panelist in this matter on June 23rd, 2016. The Panel finds that it was properly constituted. The Panel has submitted the Statement of Acceptance and Declaration of Impartiality and Independence, as required by the Center to ensure compliance with the Rules, paragraph 7.

4. Factual Background

The Complainant is a company in the UAE, experts in online used car trading and has branches throughout UAE. They hold the trademark registrations for SellAnyCar.com and BuyAnyCar.com in the UAE and European Union. The Complainant's UAE trademark SellAnyCar.com was filed on: August 19, 2013 and registered on October 8, 2014, the EU trademark was filed on April 2, 2015 and registered on February 8, 2016. Besides registering the TM as domain names in many ccTLDs with their main domain names SellAnyCar.com and BuyAnyCar.com.

The disputed domain names were registered on January 4 and October 17, 2014.

5. Parties' Contentions

A. Complainant

The Complainant is the first firm in the Middle East for online car trading since June 2013. The Complainant expertise in selling and buying used cars with three easy steps instead of long and complicated methods that were used back then.
